
## BYLAW NO 352/15 CAMPGROUND BYLAW

### A BYLAW OF THE TOWN OF STRASBOURG, IN THE PROVINCE OF SASKATCHEWAN TO REGULATE THE USAGE, FEES, AND ENFORCEMENT OF THE LIONS' PARK CAMPGROUND

The Council of the Town of Strasbourg in the Province of Saskatchewan enacts as follows:

1. For the purpose of this Bylaw, the expression:
  - a) "Campground" means Lions' Park Campground;
  - b) "Council" means the Council of the Town of Strasbourg; and
  - c) "Municipality" means the Town of Strasbourg.
2. All patrons of the Campground must abide by the rules and regulations listed in Schedule "A" of this Bylaw.
3. The prescribed fees for the campground are listed in Schedule "B" of this Bylaw.
4. The Campground can be enforced by the Bylaw Enforcement Officer or any other designate of the Municipality's choosing. The enforcement includes collecting payments and issuing receipts, performing campground checks, camper eviction, and any other duty the Council and Administrator deem necessary for the Campground.
5. This Bylaw shall come into force on the date of final approval by the Council of the Town of Strasbourg.

## SCHEDULE "A" TO CAMPGROUND BYLAW

### Campground Rules and Regulations

The Town of Strasbourg Council has set the following rules and regulations regarding the Lions' Park Campground:

1. The campground is on a first-come, first-serve basis. Sites are not reserved.
2. There are twenty-eight (28) 15-amp sites and nine (9) 30-amp sites in the newer area of the campground, three (3) 15-amp sites in the older area of the campground, and three water taps.
3. All grey/black water must be contained and disposed of at trailer dumpsite located beside the port-a-potty. Disposal of grey/black water on ground is strictly prohibited.
4. Open campfires are not allowed unless if provided barbecue stands are used. Please be advised that the Town can impose fire bans.
5. Alcohol is not permitted outside of your tent or trailer.
6. Campground fees must be paid at the Town Office Monday-Friday 8:30 a.m. – 12:00 p.m. and 1:00 p.m. to 4:00 p.m. After hours, fees need to be paid at Diger's Service Station across Highway 20. Bylaw Enforcement Officer will collect fees and issue receipts or the campground as well.
7. Campground is enforced. Ensure that you have receipt of payment for campground fees to present at random spot-checks.
8. All bylaws enacted in the Town of Strasbourg apply to the campground.



## SCHEDULE "B" TO CAMPGROUND BYLAW

The prescribed fees for the Lions' Park Campground in Strasbourg are as follows:

1. Daily Rate - \$20.00
2. Weekly Rate - \$100.00
3. Monthly Rate - \$400.00
4. Seasonal Rate - \$1000.00
