## BYLAW NO 366/16 BYLAW ENFORCEMENT OFFICER BYLAW

# A BYLAW OF THE TOWN OF STRASBOURG, IN THE PROVINCE OF SASKATCHEWAN TO APPOINT A BYLAW ENFORCEMENT OFFICER

The Council of the Town of Strasbourg in the Province of Saskatchewan enacts as follows:

- 1. For the purpose of this Bylaw, the expressions:
  - a) Council The mayor and councillors of the municipality elected pursuant to the provisions of The Local Government Election Act.
  - b) Municipality The Town of Strasbourg.
- 2. Council hereby appoints the *Commissionaires South Saskatchewan* as the Bylaw Enforcement Officers for the Municipality.
- 3. The appointment shall commence May 1, 2016 and shall continue on an annual basis, as per Schedule "A", unless the appointment is terminated by Council or the Bylaw Enforcement Officers by giving sixty (60) days written notice.
- 4. The duties of the Bylaw Enforcement Officers shall be:
  - To enforce specific municipal bylaws, enacted by the Council of the Municipality, as listed in Schedule "B" of this Bylaw;
  - b) To represent the Municipality before a justice of the peace or provincial court judge in the prosecution of anyone who is charged with contravention of a Bylaw; and
  - c) Other duties as assigned by Council or its delegate.
- 5. Bylaw No. 350/15 being a Bylaw to Appoint a Bylaw Enforcement Officer is hereby repealed.

This Bylaw shall come into force on the date of final approval by the Council of the Town of Strasbourg.

#### SCHEDULE "A" TO BYLAW ENFORCEMENT OFFICER BYLAW

### **By-Law Enforcement Contract**

This is to confirm that The Town of Strasbourg has agreed to extend contracted services with Commissionaires South Saskatchewan as By-Law Enforcement Officers.

Particulars of the agreement are as follows:

- Town of Strasbourg to provide Commissionaires South Saskatchewan with copy of Council's motion giving authority to enforce by-laws on behalf of the Town for the period under commitment.
- A letter of appointment listing enforceable by-laws dated April 9<sup>th</sup>, 2015 is on file and will
  continue to be in force. Additions or amendments permitted as reviewed and agreed to
  by both parties.
- Contract to be in the amount of \$6,182.40 which includes GST. Service as follows:
- 4 hours weekly from May 2<sup>nd</sup> 2016 to October 29<sup>th</sup> 2016 (26 weeks) 104 hours.
- 4 hours monthly from November 1st 2016 to April 30th 2017 (6 months) 24 hours
- Total 128 hours
- Contract expiry date April 30<sup>th</sup> 2017.

Town of Strasbourg requests option to increase hours / visits if required and may also request additional by-law enforcement services for specific events during the contract year. It is agreed they will provide sufficient notice (minimum 10 days) to Commissionaires for this service, costs will be paid separately from this contract.

- Cost of service at \$46.00 per hour plus GST includes Commissionaire on duty, any special meetings, administration and provision of vehicle, which includes travel time to and from Regina. During this contract travel time to and from Regina will be shared with several neighboring communities.
- Services invoiced monthly.
- Town of Strasbourg continues to provide ticket books, warning notifications and any other required notice documents.
