

A BYLAW OF THE TOWN OF STRASBOURG IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR THE LICENCING OF OCCUPANTS OF TRAILERS, MOBILE HOMES AND PORTABLE SHACKS.

The Council of the Town of Strasbourg in the Province of Saskatchewan enacts as follows:

1. Every occupant of a trailer, mobile home, or portable shack, located in the Town and used for residential purposes for a period of thirty days or more shall obtain a Licence from the Town Administrator.
2. The schedule of fees for a Licence shall be based on floor area rather than maximum outside measurements and shall be as follows:

Less than 300 square feet -	\$ 6.00 Per Month
301 - 400 square feet -	8.00 Per Month
401 - 500 square feet -	10.00 Per Month
501 - 600 square feet -	12.00 Per Month
601 - 700 square feet -	13.00 Per Month
701 - 800 square feet -	14.00 Per Month
801 - 900 square feet -	15.00 Per Month
901 - 1000 square feet -	16.00 Per Month
1001 - 1100 square feet -	17.00 Per Month
1101 - 1200 square feet -	18.00 Per Month
1201 - 1300 square feet -	19.00 Per Month
All over 1301 square feet -	20.00 Per Month

3. Where it is determined that any trailer, mobile home, or portable shack is located for some time within and for some time not within an approved trailer camp but is located within the Town for a period of thirty days or more, the Licence fee payable shall be in accordance with the schedule set out in Section 2 of this Bylaw.

4. Any person found guilty of an infraction of the provisions of this Bylaw shall be subject to the penalties provided in the General Penalty Bylaw of the Town.

5. This Bylaw shall come into force and take effect on December 1, 1972, after first having received the approval of the Minister of Municipal Affairs of Saskatchewan.

BYLAW NO. 95/76

A BYLAW OF THE TOWN OF STRASBOURG TO
AMEND BYLAW 71/72, KNOWN AS THE
TRAILOR LICENCING BYLAW

The Mayor and Council of the Town of Strasbourg, in the Province of Saskatchewan, hereby enacts as follows:

1. That bylaw No. 71/72 is amended in the manner hereinafter set forth.
2. Section (2) is repealed and the following substituted therefor:

(2.) The schedule of fees for a Licence shall be based on floor area rather than maximum outside measurements and shall be as follows:

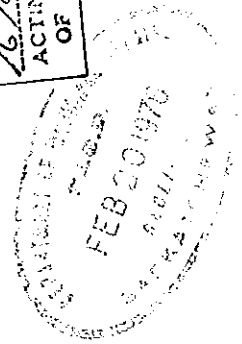
