



## BYLAW NO. 437/23 PUBLIC ALCOHOL CONSUMPTION BYLAW

### A BYLAW OF THE TOWN OF STRASBOURG, IN THE PROVINCE OF SASKATCHEWAN, TO PERMIT THE CONSUMPTION OF ALCOHOL IN OUTDOOR PUBLIC PLACES

**WHEREAS** Section 107 (4-9) of *The Alcohol and Gaming Regulation Act, 1997* authorizes municipalities to enact a bylaw designating an outdoor public place, or part thereof, as a place where alcohol may be consumed during certain hours; and

**WHEREAS** the Council of the Town of Strasbourg deems it expedient to designate certain outdoor public places owned by the Town within the Town boundaries where Alcohol may be consumed;

**NOW THEREFORE**, the Council of the Town of Strasbourg, in the Province of Saskatchewan, enacts as follows:

#### 1. DEFINITIONS

1.1 In this Bylaw:

- a. **Act** - *The Alcohol and Gaming Regulation Act, 1997* and *The Alcohol and Gaming Regulation Amendment Act, 2022*.
- b. **Alcohol** - Beer, wine, spirits, or other products that are intended for human consumption and that contains more than one percent (1%) alcohol by volume.
- c. **Administrator** - The person appointed as Administrator pursuant to Section 110 of *The Municipalities Act*.
- d. **Council** - The Mayor and Councillors of the Town elected pursuant to the provisions of *The Local Government Election Act, 2015*.
- e. **Designated Officer** - The RCMP or any other person designated by the Council or Administrator to enforce bylaws.
- f. **Permitted Outdoor Public Place** - An outdoor public place or part of an outdoor public place that is owned by the Town and has been designated by Council in this Bylaw as a place where alcohol may be consumed, but does not include a building, structure, vehicle, or other installation within the outdoor public place unless that has been expressly designated by Council in this Bylaw.
- g. **Sign/Signage** - Any printed material that guides, informs, warns, or directs.
- h. **Town** - The Town of Strasbourg.

#### 2. DESIGNATION OF PERMITTED OUTDOOR PUBLIC PLACES AND HOURS

2.1 Outdoor Public Places or parts thereof described in Schedule "A" of this Bylaw and further identified by signage posted in accordance with this Bylaw are hereby designated as Permitted Outdoor Public Places where Alcohol may be consumed.

2.2 Alcohol may be consumed in any of the Permitted Outdoor Public Places from 11:00 a.m. to 10:00 p.m. the following day, seven (7) days a week.

2.3 A person shall not consume Alcohol in parts of Outdoor Public Places that:

- a. Are outside the boundaries of the Permitted Outdoor Public Places;
- b. Is under the legal age to consume Alcohol in the Province of Saskatchewan; or
- c. Outside the permitted hours of 11:00 a.m. to 10:00 p.m. the following day.

**3. SIGNAGE**

3.1 Signs setting out the boundaries of each Permitted Outdoor Public Place and the hours during which Alcohol may be consumed in the Permitted Outdoor Public Place must be posted.

3.2 Signs posted in Permitted Outdoor Public Places designating where Alcohol may be consumed must:

- a. Be at least 12 inches by 18 inches in size;
- b. Have at least four (4) signs to designate the boundaries of the Permitted Outdoor Public Place;
- c. State the hours that Alcohol may be consumed; and
- d. Be posted or affixed to other items forming the boundary of the Permitted Outdoor Public Place.

**4. SEVERABILITY**

4.1 If any section, subsection, clause or sub-clause of this Bylaw is, for any reason, held to be invalid by the decision of a court of competent jurisdiction, it will be severed and the validity of the remaining provisions of this Bylaw will not be affected.

**5. ENFORCEMENT**

5.1 The Designated Officer is hereby given authority to enforce any and all provisions of this Bylaw.

**6. EFFECTIVE DATE OF BYLAW**

6.1 This Bylaw shall come into force on the date of final approval by the Council of the Town of Strasbourg.
