BYLAW NO. 435/23 MUTUAL AID AREA BYLAW

A BYLAW OF THE TOWN OF STRASBOURG, IN THE PROVINCE OF SASKATCHEWAN, TO ENTER INTO AN AGREEMENT TO ESTABLISH A FIREFIGHTING MUTUAL AID AREA

The Council of the Town of Strasbourg in the Province of Saskatchewan, under the provisions of Clause 42(1)(a) of *The Municipalities Act*, enacts as follows:

1. The Town of Strasbourg is hereby authorized to enter into an Agreement with the Councils of the:
 - a. Town of Nokomis
 - b. Town of Govan
 - c. Rural Municipality of Last Mountain Valley No. 250
 - d. Village of Duval
2. The terms of the Agreement are defined in the "Mutual Aid Agreement" between the parties involved in Schedule "A," which is attached hereto and forms part of this Bylaw.
3. The Mayor and the Administrator of the Town of Strasbourg are hereby authorized to sign the Agreement on behalf of the Town and affix thereto the corporate seal of the Town.
4. This Bylaw shall come into force and take effect on the final date of passing by Council.
